Welcome new and returning Holy Trinity Summer Camp Parents and Guardians!

Mr. Ibrahiym Gladney, the physical education teacher at George Washington Carver Elementary School, will be returning for his 8th year as the Holy Trinity Summer Camp Director. Mr. G and I are working hard to plan a fun, exciting, energy-intensive season that includes all of the favorite weekly trips (swimming, movies and skating); the outstanding, highly-successful weekly competition to foster sportsmanship, teamwork, healthy living and positive self-esteem; and the favored Friday trips. As always, our goal is to make this summer great and an experience that will encourage you and your children to return year after year! The full summer camp itinerary will be disclosed at **Parent Orientation Night**, which will be held on **Tuesday, June 25, 2019 at 6:30pm**. Please be sure to attend in order to receive all pertinent information necessary for your children's first day of camp.

Prior to this year, we hadn't raised our rates in three years. However, this year, to accommodate rises in our expenses we have raised our rates as follows: the registration fee is \$310; the weekly fee is \$115; and the Friday trip prices will remain at \$35/trip/child unless otherwise indicated. We are again offering savings with the "early-bird special," in which we charge the \$110 per week rate for the entire summer if the registration fee and the first two weeks of camp (\$415) is paid in advance by Tuesday, June 25, 2019. Furthermore, we are capping enrollment at 50 campers unless we have a substantial number of campers on the waiting list once we've reached 50. As such, spaces are extremely limited and are available on a first-come, first-served basis. **Campers whose attendance will be at least 87% (7 of 8 weeks attendance) will receive priority. You will need to indicate the weeks of service needed when filling out the registration form and will be charged for those weeks indicated regardless of actual attendance, except in extreme circumstances.**

This year, summer camp will begin on Monday, July 1<sup>st</sup> and run for 8 weeks, ending on Friday, August 23, 2019. The registration form must be completed online on our website at [www.htassc.org](http://www.htassc.org). Please visit the "Registration" tab for the form required to be completed and all other pertinent information (check out the other tabs). The registration process is not complete until you have paid a fee as outlined below to hold a space for your child. If taking advantage of the early-bird special as noted above is not feasible for you, alternatively you can hold a space for your child in one of two ways: (1) pay the full registration fee of \$310 or (2) pay a \$50 deposit towards the registration fee. The remainder of the registration fee is due the first day of camp, July 1, 2019. For parents who have Programs for Parents, a \$40 deposit per child is required to hold a place for your child. We will only collect the \$40 deposit once we have filled out all required PFP forms. Once we receive your online form, you will be sent an invoice via email in the amount you specify to hold your child's spot (you will have an option to choose 1 of the methods within the form). You will receive an invoice in that amount with a "Pay Now" option in which you can pay with your debit/credit card or your bank account.

Please note that your child **WILL NOT** be able to attend Holy Trinity Summer Camp until all balances due to Holy Trinity Summer Camp (from last summer) or Holy Trinity Afterschool Program are resolved. **Spaces will not be held without the proper payment as noted above.** Should you have any questions or concerns or need to resolve any past due balances feel free to contact me via email at [registration@htassc.org](mailto:registration@htassc.org), via text at 201-618-4957, or via phone at 973-678-4130 (please leave a message and I will return your call).
